Program Links Employers with Community Organizations to Help Put Americans Back to Work

Washington, DC—HR Policy Association, representing the chief human resource officers of more than 300 of the largest employers in the United States has teamed up with “A Million Jobs for America” in an effort to put Americans back to work by linking businesses with community organizations through a job bank of one million immediate job openings across the country.

“The HR Policy Association enthusiastically supports ‘A Million Jobs for America’ and its mission of helping the unemployed and underemployed find meaningful work,” said Jeffrey C. McGuiness, President and CEO of the HR Policy Association. “HR Policy Association members represent some of America’s largest employers who are creating thousands of well-paying jobs and opportunities. By partnering with non-profit agencies that support veterans, the disabled and other diverse groups of job seekers, ‘A Million Jobs for America’ provides a unique opportunity for our members to connect with the communities where they do business.”

“A Million Jobs for America” is focused on helping Americans who most need employment. Job openings are distributed directly to veterans groups, disabled individuals, non-profit organizations and state unemployment offices. In turn, employers who hire these qualified candidates may be eligible for federal tax credits, such as Restore Employment Act (HIRE) Credits and Work Opportunity Tax Credits.

Job openings are offered from employers of some of the largest corporations in America, as well as small and mid-sized firms. Employers are invited to post their jobs openings for free and the job openings range from minimum wage retail positions to highly skilled scientific and technical openings with employers across the United States. As of today, nearly 600,000 jobs have been listed in the job bank, with hundreds more added daily.

“Who better than American business to lead the job creation efforts and help get Americans back to work?” asked Mark S. Andrekovich, Chief of Human Capital and President of MAXIMUS Tax Credit and Employer Services, the sponsor leading this effort to bring businesses and community organizations together.
